### Dear JCS Family,

JCS services thousands of clients per year across more than 45 programs representing nine core pillars ranging from Behavioral Health to Senior Services. JCS assists clients in every zip code in Miami-Dade County and provides services regardless of age, race, religion, national origin or sexual identity.

In addition to these lives touched, JCS has made huge strides in improving services and providing emergency relief in the past year.

Here are our highlights:

### **Switchboard/Family Counseling Services**

It was a seamless transition when the Switchboard 211 /Family Counseling Services team came onboard on January 1, 2017. JCS was entrusted with grants from United Way, The Children's Trust, Our Kids, and South Florida Behavioral Health Network. In addition, we acquired new federal grant funding to provide trauma focused counseling to youth and their families in underserved communities. Our 75 new staff members are proud to be a part of JCS and we are thrilled to have them!

### ReadyCare

Just a little over one year since beginning our Medicare certified home health agency in partnership with Brightstar, we are showing positive cashflow.

### **New & Expanded JCS Kosher Food Bank**

We have officially moved in to the new JCS Kosher Food Bank at 2056 NE 155th Street North Miami Beach, FL 33162, a 4,500 square foot state of the art warehouse that is 3x the size of its original location! The generosity of JCS' incredible donors and volunteers has played a critical role in the development of our new and improved Kosher Food Bank.

### **Hurricane Irma Relief Efforts**

As one of the largest human services organizations in Miami-Dade County, JCS mobilized to provide emergency services and food deliveries as well as information and referrals to thousands of Miami-Dade residents in need.

Looking towards the future, JCS faces several challenges and many opportunities, including our 100th anniversary celebration in 2020. Together, we will face these challenges ranging from increased demand for food at our Kosher Food Bank, senior meal sites and home deliveries to more specialized services for our aging Holocaust Survivor population.

As we look toward our 100th anniversary in 2020, JCS, with your help and support, will continue to make a meaningful impact in our community as we enter our second century.


